- Updated annual review process Lindsey and Lisa discussed ways to improve the annual review process, historically done in January with increase effective 2/1. Looking at changing annual review period to May, with increases effective 7/1 to align goal setting with fiscal year. Also dicussed developing more measurable goals that support employee growth including goals in three main areas: company (board-initialed), team goal, personal development goal. Review process will include 360 degree feedback for each staff member. Lisa Soboslai will chair committee for Lindsey's ED review. To ease into this new process, 2023 will be a transition year partial increase in February, eligible for partial increase in July, then following year increase in July.
- **Connections update** Lindsey shared that we will be sticking with quarterly connections for the immediate future due to staff capacity. Not enough volunteers to write throughout the year, so quarterly schedule gives staff time to develop stories. Also looking into other printing options.
