- Investment Strategy Michele shared an update on the investment strategy.

• Crime and Safety – Board discussed neighborhood safety and recent reports of home burglaries.

Partner Organization Updates:

- IHCA Sarah shared about the upcoming annual meeting at Blakely Hall on 26th, Rossie Cruz did not re-run for board, Katia running for city council, formation of playground committee, moving to new software in next few months, board approved temporary AC units, must be removed by October.
- **HFN** Jeremy shared that HFN has adopted plan to overhaul network over the next 3-4 years replacing electronics in home and data center, lowering energy consumption, will be able to offer 10 gig, then 25-50 gig in the future.
